_____	_____	Brake Fluid	Proper level. Fresh DOT 4/DOT 5 brake fluid bled within last 60-90 days. Date of last bleeding: _____
_____	_____	Brake Pads	Adequate pad/shoe thickness.
_____	_____	Fluids	No fluid leaks of any kind.
_____	_____	Suspension	No play in ball joint, tie rod ends, steering or wheel bearings. Shocks/struts in good condition.
_____	_____	Axle Boots/CV Joints	Good condition.
_____	_____	Exhaust System	No holes or leaks.
_____	_____	Body	Sound condition in all critical suspension mounting points. Car must be present in overall good condition. No excessive rust.
_____	_____	Seat Belts	No frayed or worn seat belts. Secure mounting points. Equal restraint rule is in effect. If you have upgraded the driver's side you must place similar equipment in the passenger side for your instructor. If using competition type 4 or 5 point, most sanctioning bodies recommend replacement every 3-5 years.
_____	_____	Mirrors	At least one functioning rearview mirror.
_____	_____	Windshield	No cracks.
_____	_____	Wipers	Good working condition.

_____	_____	Fire Extinguisher	Highly recommended but not required by KCRPCA. The car you save may be your own. Recommend 2.5, 16 minimum BC rated metal to metal mounting within reach of driver.
_____	_____	Passenger Seat	Required for your instructor unless you are in an advanced or instructor group.
_____	_____	Roll Bar	Any open car with factory rollover protection is acceptable. All non-original equipment roll bars must be approved prior to the event.
_____	_____	Brake Lights	Functioning properly.
_____	_____	Battery	Securely held down.
_____	_____	Wheels	Straight, no cracks.
_____	_____	Tires	No cord, cracks in sidewalls. Adequate tread depth.

_____	_____	Helmet	Must have a Snell 2000 or newer sticker inside the helmet. Snell SA (Special Application) is preferable to MA (Motorcycle Application) but either is acceptable. If you have any questions on this please call.
_____	_____	Loose Objects	All loose objects should be removed from the car. Lock the glove compartment and empty all trunks and storage compartments. Clean up loose change, CD's or any other objects that can move and distract the driver.
_____	_____	Auxiliary Equipment	All cellular phones, stereo equipment, video cameras or equipment such as the "G" analyst must be securely mounted if remaining in the car. Those not hard mounted should be removed.
_____	_____	Wheel cover/Wheel Locks	Removed.
_____	_____	Wheel Lugs	Check when cold; must be properly torqued. Verify that all wheel spacers with separate studs/lugs are torqued.
_____	_____	Gas Cap	Intact and tight.
_____	_____	Clothing	Smooth sole shoes, socks, shirt and long pants.
